Overview

Corruption exacerbates gender inequalities and prevents women from gaining access to their civil, political, social and economic rights. This has a detrimental impact on the achievement of the Sustainable Development Goals (SDGs). With over a decade of experience supporting the implementation of anti-corruption and integrity reforms in the Arab states region, the United Nations Development Programme (UNDP) is working to tackle a dual development challenge. On the one hand, women's voices are underrepresented in public affairs and policymaking. On the other hand, while corruption affects everyone, women tend to be more severely affected by certain forms of corruption and are disproportionately impacted in many sectors including healthcare, education and doing business.

The UNDP Regional Hub for Arab States is organizing the 2nd regional meeting of the *Regional Alliance of Women Against Corruption that* will be held on 25-26 July 2022 in Brummana, Lebanon with the possibility of online participation via Zoom. The emerging regional network is comprised of women who are in positions to lead efforts aimed at integrating a gender lens into anti-corruption and integrity reforms across the region, including in related national and sectoral strategies.

The event will bring together more than twenty women from the region who are active in leading dialogues and initiatives to strengthen transparent and accountable governance and tackle corruption, including women in government, business, civil society and academia. To frame this discussion, UNDP will present an issues paper on global as well as regional trends and research at the intersection of anti-corruption and gender. This will be followed by presentations by different international inter-governmental or civil-society organizations on the relationship between gender and corruption. A round table discussion of Arab country experiences will highlight concrete corruption-related challenges the region faces. This will prepare the working session that UNDP will facilitate for the Women's Alliance for Anti-Corruption and Integrity in Arab Countries to review and discuss the network's concept and activities plan.

This regional meeting is part of the ongoing partnership with the Government of Canada in the framework of UNDP's regional project on Anti-Corruption and Integrity in the Arab Countries (ACIAC). UNDP will draw on the conclusions of this regional meeting to support women and other stakeholders to closely examine and better tackle the gender dimensions of corruption and promote gender-sensitive approaches to anti-corruption and integrity reforms.
