Overview

The United Nations Development Programme (UNDP) is organizing a workshop in Istanbul, Turkey, from 9 until the 11th of October 2022 within the framework of UNDP's regional project on Anti-Corruption and Integrity in the Arab Countries (ACIAC), which is implemented in partnership with the Korean International Cooperation Agency (KOICA).

The workshop provides an opportunity to discuss and advance the prioritized framework of the regional project on the nexus between corruption and energy, education, health, water, and transport in the Arab Region, including the integration of gender perspectives.
