



PREVENTION	Design and implementation of: the Internal Control System (internal audit units and standards) the National Integrity System (Integrity Advisers, codes of ethics and conduct, conflict of interest guides) & Sectorial anti-corruption strategies et.al.
RAISING AWARENESS	Promote trust in public institutions, educate the youth, engage citizens and civil society organizations as stakeholders in the fight against corruption

Memorandums of Understanding (MoUs)

MINISTRY OF EDUCATION, RELIGIOUS AFFAIRS AND SPORTS

- 1. The NTA provides expertise and advisory services on issues related to:
 - (a) internal audit and
 - (b) strengthening of integrity mechanisms and implementation of integrity tools and policies
- 2. Aims to promote a culture of integrity and accountability in the educational community through seminars, workshops and training programs, targeted at all educational institutions, and
- 3. Develops a specific sectoral strategy to raise awareness against corruption.

Raising Student Awareness on Integrity Issues




The UNODC, in cooperation with the NTA, the Ministry of Education and the Institute for Educational Policy, organized seminars for primary and secondary school teachers.

The aim of the project was to familiarize teachers with the special "Empowering Students for Just Societies" Handbooks which were translated and adapted to the Greek setting.

Aim: To provide teachers with a selection of relevant and accessible in-classroom and out-of-classroom educational resources that aim to instill the principles of the RoL among students.






