

## Towards a Regional Alliance of Women Anti-Corruption and Integrity Leaders

# Third Regional Meeting

7-8 November 2022 Amman, Hashemite Kingdom of Jordan



# Programme

## Overview

The UNDP Regional Hub for the Arab States is organizing the third regional meeting for women leaders in the field of anti-corruption and integrity in Arab countries in collaboration with Global Affairs Canada. The meeting, which will be held in Amman in the Hashemite Kingdom of Jordan on 7 and 8 November 2022, will be attended by leading women in government, civil society, academia, and the business community as well as experts, representatives of concerned regional international organizations, and senior public officials responsible for developing and implementing national anti-corruption strategies.

The regional meeting will enable participant to engage in exploring the gender perspectives in existing national anti-corruption strategies based on the Issues Paper that has been prepared by UNDP in this regard. Then they will proceed to identify and discuss related public policies and measures that are gender-sensitive and that account for women perspectives and development priorities and needs with due considerations given to national priorities and relevant elements in each country's context.

More specifically, joint discussions will allow an active exchange of concrete evidence over gender dimensions in national anti-corruption strategies, including on the inclusion of women's contributions and concerns into the development, implementation, monitoring, and reporting of these strategies. This will allow participants to identify whether national processes and debates have so far paid attention to differentiated gender perceptions and experiences on corruption and integrity. Based on that, it is expected that participants will become better prepared to explore concrete approaches to building integrity systems responsive to women's needs as well as good practices to mainstreaming gender considerations into related reform policies and programs will be discussed.

The Issues Paper prepared by UNDP offers a starting point for these joint discussions focusing on the current anti-corruption strategies of Jordan, Lebanon, and Iraq as case studies. It complements the first Issues Paper that was developed by UNDP on the nexus between corruption and gender, with this paper taking the regional dialogue a step further.

Accordingly, UNDP will draw on the conclusions of this regional meeting to support women and other stakeholders to closely examine and better tackle the gender dimensions of corruption and promote gender-sensitive approaches to related reforms in the context of national anti-corruption and integrity strategies.
