## Overview of the Non Governmental Group of ACINET

The Non Governmental Group of ACINET was established on 27 July 2010 as an autonomous component of ACINET, which is considered to be the leading regional mechanism specialized in supporting Arab countries to act against corruption, in line with their national priorities, and drawing on global and regional standards. ACINET brings together 37 national authorities in 15 Arab countries, namely Bahrain, Djibouti, Egypt, Iraq, Jordan, Lebanon, Libya, Mauritania, Morocco, the occupied Palestinian territory, Qatar, Saudi Arabia, Sudan, Tunisia, and Yemen. The Group aims to enable related nongovernmental actors to participate effectively in the activities of ACINET and enrich the national related efforts. The Non Governmental Group strengthens the capacity of such actors to support the enforcement of the United Nations Convention Against Corruption and encourage dialogue between governmental and non-governmental actors and support joint and collective action initiatives as well as communication between the Arab region and other regions to promote sharing anti corruption expertise and experiences. Membership of Group is open to all actors in civil society, private sector, media and academia and research in accordance with the criteria set in the Rules and Procedures.
