Tunis, 1-3 June 2016

**Programme**

## Overview

Under the patronage of the Minister of Public Function, Governance and Anti-Corruption in the Republic of Tunisia, the regional workshop on “strengthening transparency and accountability in priority sectors in the Arab region” is convened in Tunis on 1-3 June 2016, organized by UNDP’s Regional Hub in the Arab States, in cooperation with the “Arab Anti-Corruption and Integrity Network’ (ACINET) and the support of the Siemens Integrity Initiative.

The event is based on the results of the regional consultations that were held by UNDP in 2014, which had called for strengthening collective action against corruption and supporting specific preventive initiatives in sectors that deliver basic services to people and generate considerable funds for the State, thus having a direct impact on the sustainable development agenda. As such, the event, which brings together more than sixty experts from the region and beyond, including independent experts and representatives from relevant ministries, agencies and relevant organizations from 9 Arab countries, aims to establish a common interactive space for expert stakeholders to exchange views on how to support collective action against corruption on the one hand, and what approaches are most suitable to reduce corruption risks in priority sectors in Arab countries on the other, while also enabling them to participate in the development of specialized tools on collective action and transparency and accountability in the health, customs and justice sectors drawing on related international standards and comparative experiences.

The regional workshop begins its first day with two plenary sessions on good practices and lessons learned on sectoral initiatives on the one hand, and collective action on the other, while exploring related efforts in the Arab region, available opportunities and existing challenges. Based on those two plenary sessions, participants divide into four working groups to contribute to the development of specialized working tools in four key areas, and then reconvene in a final plenary session to present their findings and recommendations.

- Working Group (A) will crystallize conclusions and recommendations to contribute to the development of specialized training materials that may be used by anti-corruption agencies in Arab countries to strengthen collective action against corruption at the national and local levels. Discussions will focus on a number of topics moderated in an interactive manner by experts from UNDP and ACINET. The Working Group will select a rapporteur to present the conclusions and recommendations during the final plenary session.
- Working Group (B) will crystallize conclusions and recommendations to contribute to the development of a practical guide for assessing and managing corruption risks in the health sector as well as specialized training materials that may be used by key stakeholders in Arab countries to strengthen transparency and accountability in this sector. Discussions

will focus on a number of topics, moderated in an interactive manner by experts from UNDP and the World Health Organization. The Working Group will select a rapporteur to present the conclusions and recommendations during the final plenary session.

- Working Group (C) will crystallize conclusions and recommendations to contribute to the development of a practical guide for assessing and managing corruption risks in the customs sector as well specialized training materials that may be used by key stakeholders in Arab countries to strengthen transparency and accountability in this sector. Discussions will focus on a number of topics, moderated in an interactive manner by experts from UNDP and the World Customs Organization. The Working Group will select a rapporteur to present the conclusions and recommendations during the final plenary session.
- Working Group (D) will crystallize conclusions and recommendations to contribute to the development of a regional tool that may be used by ACINET to monitor the state of integrity in the justice sector in Arab countries, starting with the judiciary and prosecution. Discussions will focus on a number of topics, moderated in an interactive manner by experts from UNDP and the UN Office on Drugs and Crime. The Working Group will select a rapporteur to present the findings and recommendations during the final plenary session.

The event is expected to provide a solid, evidence-based, participatory platform to advance the development of specialized working tools that would enrich regional efforts on collective action against corruption and specific preventive initiatives in priority sectors in Arab countries, while also opening the door for expanding related efforts to new sectors, thus contributing to a qualitative leap in processes of national anti-corruption strategies, which are rapidly growing in the region but are yet to achieve satisfactory results for ordinary citizens as well as decision-makers.
